## **NOTICE - IITF 2025 MARQUEE PARTICIPATION**

India Trade Promotion Organisation (ITPO) will be organizing the 44<sup>th</sup> edition of India International Trade Fair (IITF), at Bharat Mandapam (New Delhi), from November 14-27, 2025.

2. The booking of space by private entities for participation in the exhibition will be through ITPO's new online booking portal <a href="https://booking.indiatradefair.com/login">https://booking.indiatradefair.com/login</a>. All interested exhibitors will be required to complete the mandatory account creation/registration process and pre-registration for IITF through this new portal. - 3. The first stage of online bookings of IITF 2025 will be opened for Marquee Companies. The details for Marquee Company participation are given below:
  - i. Firstly, in order to participate, all applicants need to register themselves as given above.
  - ii. The qualifying criteria for any company to be considered for booking under the "Marquee" category is an annual turnover of a minimum of Rs. 50 crores during any one of the previous 05 financial years.
  - iii. The minimum booth size under the Marquee category will be 100 sqm.
  - iv. The booths will be available at a premium over and above the regular rentals. The rentals for this phase of booking by eligible Marquee Companies will be at a rate of Rs. 20,000 per sqm., exclusive of GST. (bare space) and Rs. 20,500 per sqm, exclusive of GST (shell space).
  - v. Key dates for booking process for marquee companies will be as per the table below.

- vi. Registered applicants interested to participate in Marquee bookings will be required to apply online through the portal.
- vii. After registering themselves, they will be required to upload their CA-certified Turnover documents (an annual turnover of a minimum of Rs. 50 crores during any one of the previous 05 financial years) and GST certificate.
- viii. The CA-certified Turnover document should be a single pdf file with a maximum size of 20 MB. GST certificate should be a single pdf file with maximum size of 10 MB.
- ix. A separate USER MANUAL for Marquee application is also available online on the website and portal under the link 'IITF 2025 USER MANUAL FOR MARQUEE APPLICATION'.
- x. The documents submitted by applicants will be checked for eligibility. Only approved applicants will be able to access the stall bookings that will open later for Marquee companies.
- xi. Applicants will receive updates regarding Acceptance/Rejection of their Marquee documents on their registered e-mail addresses. List of eligible Marquee companies will also be published on the website and booking portal.
- xii. The mapping of booths / halls will be based on product profile. In other words, a user will be able to book a booth in the hall earmarked for the product category selected by the user at the time of registration for IITF 2025. The mapping of category and halls is mentioned in the table below.

- xiii. The marquee companies that successfully complete their booth selection process will be required to pay 100% of the due amount through Online payment gateway (Netbanking/Credit/Debit Card) in one go during the booking or through the Challan generated online through payment gateway latest by 5.00 pm on 02<sup>nd</sup> September, 2025. Payment should be received by ITPO by the said date and time. The Challan payment option will be available in the Online Payment gateway at the time of booking.
- xiv. In case a marquee company fails to remit the payment within the stipulated date, the booth may also be released for online booking by other exhibitors.
- xv. Terms and Conditions Apply.
