### **NOTICE - IITF 2025 ONLINE BOOKINGS FOR GENERAL AND PREMIUM STALLS**

**India Trade Promotion Organisation (ITPO) will be organizing the 44<sup>th</sup> edition of India International Trade Fair (IITF), at Bharat Mandapam (New Delhi), from November 14-27, 2025.**

2. The booking of space by private entities for participation in the exhibition will be through ITPO's new online booking portal <https://booking.indiatradefair.com/login>
3. Online stall bookings for General and Premium stalls will open at **2.00 PM on September 15, 2025.**
4. All interested exhibitors will be required to complete the mandatory account creation/registration process and pre-registration for IITF through this new portal. 6. All payments will have to be made through the Online Payment gateway (Debit Card/ Credit Card/ Net Banking) at the time of the booking, within 60 minutes of adding the booth to the cart. A maximum of one booth per company may be booked by one company.
7. **Applicants who opt to make payment through CORPORATE NETBANKING (Maker-Checker) are advised to approve the payment within 40 minutes of adding the booth to the cart. Otherwise, the payment may fail and the booth may not be booked. ITPO will not be responsible for such failures.**
